***RHEP Restricted Cities:** Charleston (and South Charleston, Dunbar, Nitro, Institute); Clarksburg (and Bridgeport and Nutter Fort); Fairmont; Huntington (and Barboursville); Martinsburg, Morgantown (and Sabraton, Star City and Westover); Parkersburg (and Vienna); Weirton; and Wheeling. **Additional Cities, considered part of the eight forbidden cities:** Barboursville, Cross lanes, Dunbar, Kanawha City, Little Falls, Nitro, Ridgeley, South Charleston, and St. Albans. **Exceptions** include Federally Qualified Health Centers (FQHCs), federal 330 Clinics (CHCs), free clinics and sites that have been granted a special variance by the Executive Director of RHEP located within these restricted cities.
